PROCEEDINGS OF THE 14th BOARD OF MANAGEMENT MEETING OF MANIPUR TECHNICAL UNIVERSITY, IMPHAL HELD ON 17th MARCH, 2022

The 14th meeting of the Board of Management of Manipur Technical University, Imphal was held on 17th March, 2022 at the University campus at Takyelpat with Dr. Bhabeswar Tongbram, Vice-Chancellor of the University in the chair. The following members/nominees were present in the meeting:

At the outset, the Chairman of the Board of Management welcomed all the members of the Board of Management of Manipur Technical University, Imphal. The agenda set for the meeting were discussed one after another and resolutions taken on them are as detailed below:

1. Confirmation/Review of decisions taken in the 13th meeting of Board of Management:

- (i) The Board noted that the University had updated the detail of the members of the Screening Committee for the recruitment of 31 Assistant Professors and also the University has forwarded the proposal for the change in nomenclature of 1 post of Assistant Professor for Biological Sciences and the same was approved by the State Government.
- (ii) The Board also noted that the University reconstituted the IQAC of the University with a tenure of 2 years and the inclusion of more faculties for expansion of IQAC will be taken up soon.
- (iii) The Board also noted that the University have issued appointment orders of regularization for 4 Assistant Professors and the aforesaid Assistant Professors have joined the University & started their assigned duties.
- (iv) The Board also noted that the University in consideration of pandemic of Covid-19 across the state decreased the Tuition fee amounting ₹1000/-, Institutional Development fee amounting ₹6000/- and exempted the student activity fee amounting ₹1000/- for the even semester of the academic session 2020-21 and has not increased the academic fee of library & lab fee for the academic session 2021-22 as fixed by the 13th Board of Management and it may be increased from next academic session 2022-23.
- (v) The Board also noted that a Selection Committee for the appointment of Vice-Chancellor, Manipur Technical University under section 14(1) was constituted by the State Government comprising the following:

Further, the University had issued a notification of notification no. 15/1/2016-MTU dated 12th August 2021 for the appointment of Vice-Chancellor, Manipur Technical University. Accordingly, applications were received and the selection committee held a meeting on 28th October 2021 and the committee submitted the lists of the recommended to the Chancellor, Manipur Technical University.

Furthermore, the Board also noted that an appointment order No. GSM/MU-2/2017 dated 8th November, 2021 of Governor's Secretariat, Raj Bhavan, Imphal was issued appointing Dr. Bhabeswar Tongbram as Vice-Chancellor of Manipur Technical University for a period of 05 (five) years from the date on which he enters upon his office or until he attains the age of 70 (seventy) years, whichever is earlier.

- (vi) The Board also noted that the University amended the Ordinance No.12 as Master of Business Administration Ordinance and the Course Curriculum including the Ordinance, Syllabus & Regulation with minor modification in the regulation and further suggested that the updated Ordinance No. 12 may further be amended.
- (vii) The Board also noted that the University have amended the modification of Table 23.2.1 (CGPA scale of MTU Ordinance).
- (viii) The Board also noted that the University amended para 11.3 (IX) of Ordinance 1 with the insertion of sentence as "The seats of detained students in first year will not be considered vacant until and unless they forfeit their seats themselves".
- (ix) The Board also noted that the University merged the sub-para 22.10. in the existing sub-para 22.9 of para 22 of Ordinance 1 of MTU Ordinance as Both SGPA and CGPA will be rounded off to the second place of decimal and recorded as such. Only the rounded off value of CGPA will be used for the purpose of determining the merit ranking of group of students in continuation.
- (x) The Board also noted that the University will put the proposal for approval of regulations for Ph.D Programmes in Manipur Technical University in the next Academic Council meeting.
- (xi) The Board also noted that the University is waiting for the Government decision on the proposal sent by the Manipur Technical University for recruitment of of 17 non-teaching.
- (xii) The Board also noted that the University has not introduced 1 (one) short term course per academic session in Manipur Technical University as approved in principle by the Board of Management till date. As the matter is reserved for proposing the approval of the course curriculum and regulation for short-term in the next Academic Council meeting.
- (xiii) The Board also noted that the University has amended the Ordinance No 1 (sub para no. 2.2 of para 2) of Manipur Technical University.
- (xiv) The Board also noted that the University has forwarded the Drawing, estimates & designs amounting Rs 746,99,98,000 (Rupees Seven hundred forty-six crores ninety-nine lakhs and ninety-eight thousand) only for the establishment of Permanent Campus at Khaidem Makha Leikai and Heigrujam Mamang Leikai under Patsoi sub division of Imphal West, Manipur to the Government.

2. Constitution of Departmental Promotion Committees (DPCs) for considering cases of confirmation.

(i) The Board of Management approved the proposal for constitution of Departmental Promotion Committees (DPCs) as given in Table 2A for 14 posts of Assistant professors (5 recruited in 2016 & 9 in 2018), 2 posts of Assistant Controller of Examination (1 recruited in 2018 & 1 in 2019), 1 post of Assistant Librarian recruited in the year 2018 and 1 post of Web-Administrator & 1 post of System-Administrator recruited in the year 2018 and 69 posts of Group B, C & D (in total) recruited in the year 2018, 2019 as a one-time measure for the said 88 posts.

- (ii) Further, the Board also approved the ongoing process of recruitment and advised the University to complete the recruitment process of Assistant Professors as the enforcement of model code of conduct is completed in the State
- 4. Supersession of terms in Statue 24A: Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards
- (i) The Board of Management approved the supersession of the regulations/ procedures/ norms of UGC/ AICTE followed by Manipur Technical University with effect from the date UGC/ AICTE notifies and the same is published in The Gazette Notification.
- (ii) The Board of Management resolved to adopt the UGC Regulation 2018 and AICTE Regulation 2019 with effect from the date of issue.


5. ORDINANCE-17: Desirable qualification of Vice-Chancellor

 - b) Further, the Board advised the University to include TA/DA when Legal Advisor-cum-Standing Counsel appear before any legal court situated outside the state of Manipur on behalf of Manipur Technical University.
- (ii) Establishment of Sponsored Research and Industrial Consultancy Cell.
 - The Board of Management approved the proposal for establishment of Sponsored Research and Industrial Consultancy Cell, Manipur Technical University
 - b) Further, the Board also approved the rules for Sponsored Research and Industrial Consultancy as proposed, which may be amended from time to time.
 - c) Furthermore, the Board also suggested that the University may try to collaborate with various industries/institutions for betterment of the University.
- (iii) Proposed Budget 2022-2023:
 - a) The Board of Management approved the proposed Budget 2022-2023 as proposed.
