Minutes of the 2nd Academic Council Meeting, 2017:

Imphal, the 27th May, 2017

No. 32/1/2016-MTU: The 2nd Academic Council Meeting for Manipur Technical University, Imphal was held on **27th May, 2017 at 11.00 AM** at the University campus at Takyelpat, Imphal with Shri H. Deleep Singh, IAS, Vice-Chancellor in the Chair. It was attended by three other members of the Council (copy of attendance sheet enclosed). The eight faculty members of the University were also invited to be a part of the meeting.

2. Section 44 (2) of the Manipur Technical University Act, 2016, provides that no ordinances concerning the academic matters shall be made by the Board of Management unless a draft thereof has been proposed by the Academic Council.

3. The present Ordinance1- Ordinance relating to Bachelor of Technology Programmes has provisions which are more suited to be included in the Regulations and therefore it was proposed to remove the provisions from Ordinance 1 and include them in the Regulations. The Academic Council unanimously approved the proposal.

4. The Academic Council discussed the provisions of the newly created Regulations (Bachelor of Technology Programmes), 2017 thoroughly and proposed modification/incorporation of the following points in it:

- I. The term "Course" should be defined in section 2 of the Regulations.
- II. The provisions related to Lateral Entry in section 5.2 of the Regulations as adopted from the latest AICTE notification on the matter need not be elaborated. It may be shortened with the remark that Lateral Entry to Manipur Technical University will be admissible as per AICTE/UGC/State Govt. norms as amended from time to time.
- III. The minimum requirement criteria for promotion from one year to another in B. Tech. programme is determined in terms of number of credits a student has to earn in the particular year as provided in section 25 of the Regulations. The minimum requirement criteria may be determined in terms of **number of courses a student has to pass in a particular year** and not in terms of credits he/she has to earn. The maximum number of backlog courses may be set at 03 courses per semester.

5. The Regulations (Curriculum and Syllabi for B. Tech. Programmes) in Civil Engineering, Mechanical Engineering, Electrical Engineering, Electronics and Communication Engineering and Computer Science and Engineering were placed in the Academic Council and these were unanimously approved by the Academic Council with the observation that

an exhaustive list of 'Audit Courses' should be prepared for each semester from which a student may opt for one audit course of his/her choice in a particular semester. The list of Audit Courses appended herewith at **Annexure-I** is approved by the Academic Council for introduction to B. Tech. Programme in Manipur Technical University.





